Special Workshop:

Mayor Thompson began the interviews for Richland Public Facilities District Board vacancies at 5:30 p.m. in the City Manager's Conference Room in the City Hall Annex building.

City Council Workshop – 6:00 p.m. (City Hall Council Chamber)

Mayor Pro Tem Christensen called the City Council Workshop to order at 6:02 p.m.

Attendance:

Mayor Pro Tem Christensen, Councilmembers Anderson, Kent, Lemley and Luzzo Gilmour were present.

Also present were City Manager Reents, City Attorney Kintzley, Energy Services Director Hammond, Fire and Emergency Services Director Huntington, Community Development Director Jensen, Public Works Director Rogalsky, Transportation and Development Manager Peters, Development Services Manager Simon and City Clerk Hopkins.

Mayor Pro Tem Christensen led the Councilmembers and audience member in the Pledge of Allegiance.

Agenda Items:

- 1. Power Purchase Discussion (20 minutes)
 - Bob Hammond, Energy Services Director

Mr. Hammond gave the following report: The City of Richland has entered into a Power Sales Agreement with the Bonneville Power Administration (BPA) covering wholesale power purchases by the City's electric utility through year 2028. As a condition of this agreement, no later than September 30, 2016, the City must specify to BPA the amount of non-federal power the City wishes to secure for years 2020 through 2024.

Energy Services Department (RES) staff have worked over the past 12 months with Northwest Energy Management Services (NEMS) to develop a policy framework to use for finalizing a recommendation that balances fiscal responsibility/strength of the utility with future power market risk considerations.

Using the policy recommendation developed with assistance from NEMS, RES staff have worked closely with the City's Utility Advisory Committee (UAC) during regular and special committee meetings to finalize a recommendation for Council consideration at its August 2, 2016 meeting.

Councilmembers discussed Mr. Hammonds report and asked clarifying questions.

Island View Street Standards (20 minutes)
 Pete Rogalsky, Public Works Director

Mr. Rogalsky said the purpose of this workshop item is to solicit Council guidance related to staff recommended development requirements for a portion of the Island View area. He said since the late 1990's, City planning documents have pointed to redevelopment of Island View properties from single family residential to commercial uses. These planning goals are represented in the City's Comprehensive Land Use Plan designations. Complimenting these land use goals, is an assessment indicating the street network that was platted and constructed to support the residential development, has more tightly spaced streets than is needed to support the desired redevelopment. Segments of Carolina Avenue, Dakota Avenue, Geneva Street, Denver Street, and Carson Street have been deemed unnecessary.

Activating this planning concept presents challenges, mostly because there are many small parcels under separate ownership whose owners have varying plans for the future. Current municipal code for development projects requires street construction elements, including curb, gutter and sidewalk on all public streets at the time of building permit.

Application of this code provision to permit applications along the streets listed above will result in a potential patchwork of isolated street improvements that won't contribute to the planning goals included in the City's Comprehensive Land Use Plan. Staff has considered two actions to activate the planning goals:

- 1. Amending the municipal code to exempt permits along the listed streets from constructing the street improvements; and
- 2. Vacating the unnecessary street rights of way. Vacation automatically transfers the vacated right of way to the adjacent properties. This could result in blocking of access to current uses and cannot be done until a unified approach to an entire block is achieved. Staff intends to propose amendment of the municipal code development requirements and is seeking Council concurrence with this approach.

Council discussed the planning goals and concurred they want to consider what the recommendations the Planning Commission make after they discuss this topic at the next Planning Commission meeting.

Other Business:

Ms. Reents said the Richland School District has submitted discussion topics for the Joint Richland School District/City Council meeting scheduled for August 4, 2016. She asked Council to submit their agenda topics to her for the joint meeting agenda by the end of the week, as well.

Summary:

Recent petitions filed against the City have required the services of outside legal counsel with specialized expertise to support the City Attorney's Office in litigating these cases.

No funds were appropriated in the Industrial Development Fund to cover the legal expenses from unanticipated litigation.

\$50,000 in funding is needed to cover the legal expenses in litigating a Petition for Declaratory Order filed with the Surface Transportation Board.

\$7,500 in additional funding is needed to cover the legal expense in litigating a petition filed with the State of Washington's Eastern Washington Growth Management Hearings Board.

Fiscal Impact: The proposed budget amendment will increase appropriations by \$57,500 in the Industrial Development Fund. Sufficient unappropriated reserves are available in the Fund to cover these expenses.

ORDINANCE NO. 36-16

AN ORDINANCE of the City of Richland amending the 2016 Budget to provide for additional appropriations and declaring that a public emergency exists in the Industrial Development Fund.

WHEREAS, on November 17, 2015, the Richland City Council approved Ordinance No. 74-15 approving the 2016 Budget; and

WHEREAS, no funds were appropriated in the Industrial Development Fund to cover legal expenses resulting from unanticipated litigation; and

WHEREAS, City staff has determined that the services of outside legal counsel with specialized expertise are needed to support the City Attorney's Office in litigating recent cases brought against the City; and

WHEREAS, \$50,000 in funding is needed to cover the legal expenses in litigating a Petition of Declaratory Order filed with the Surface Transportation Board; and

WHEREAS, \$7,500 in additional funding is needed to cover the legal expenses in litigating a petition filed with the State of Washington's Eastern Washington Growth Management Hearings Board; and

WHEREAS, sufficient unappropriated funds are available in the Industrial Development Fund to support the required budget adjustment; and

WHEREAS, a public hearing was held pursuant to RCW 35.33.091 on July 19, 2016, regarding the increase in appropriations from beginning fund balance in the Industrial Development Fund.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Richland as follows:

Summary:

On April 21, 2015, Council passed Ordinance 18-15 establishing the preliminary assessment roll for the Reata Road Area Local Improvement District (LID) No. 197. Construction of water and sewer main lines in the Reata Road area west of Leslie Road, between Reata Road to the north and I-82 to the south, was completed in December, 2015. The contract was closed out and all costs evaluated in April 2016.

In accordance with state law, the City Engineer evaluated and approved the final costs for the project and oversaw preparation of the final assessments. Notice of the final assessments was provided to each affected property owner, and a public hearing to receive testimony from assessed property owners was held at the City Council meeting on July 19, 2016. No testimory was received from property owners.

Staff recommends approval of the proposed ordinance to finalize the LID and begin collection of assessments.

Total LID construction, engineering, interest and closing costs are \$612,634.38. After finalFiscal Impact:approval of the LID ordinance, scheduled for August 16, the City will accept assessmentprepayments for 30 days. After the prepayment period the unpaid balance of the LID will be
financed and the assessment collection begin with annual assessment bills to property owners.

ORDINANCE NO. 39-16

AN ORDINANCE of the City of Richland approving and confirming the assessments and assessment roll of Local Improvement District No. 197, as provided by Ordinance No. 18-15, and levying and assessing the cost and expense thereof against the several lots, tracts, parcels of land and other property as shown on the assessment roll.

WHEREAS, the assessment roll levying the special assessments against the property located in Local Improvement District No. 197, commonly known as Reata Road Area Utility Local Improvement District No. 197, in the City of Richland, Washington ("City"), has been filed with the City Clerk as provided by law; and

WHEREAS, notice of the time and place of hearing thereon and making objections and protests to the roll was published at and for the time and in the manner provided by law fixing the time and place of hearing thereon for the 19th day of July, 2016, local time, in the Council Chambers in the City Hall, located at 505 Swift Boulevard in Richland, Washington, and further notice thereof was mailed by the City Clerk to each property owner shown on the roll; and

WHEREAS, at the time and place fixed and designated in the notice, the hearing was held, all written protests received were considered, all persons appearing at the hearing who wished to be heard were heard, and the City Council, sitting and acting as a Board of Equalization for the purpose of considering the roll and the special benefits to be received by each lot, parcel and tract of land shown upon such roll, including the increase and enhancement of the fair market value of each such parcel of land by reason of the important, overruled all such protests.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Richland as follows:

<u>Section 1</u>. City Council finds that the assessment methodology used by the City in the District is fair, equitable, accurate and ratable, and is the most appropriate means of assessing the properties in the District for special benefits resulting from the improvements. The assessments and assessment roll of Local Improvement District No. 197, which has been created and established for the purpose of constructing water and sewer main lines, as provided by Ordinance No. 18-15 as the same now stand shall be and the same are approved and confirmed in all things and respects in the total amount of \$612,634,38.

Section 2. Each of the lots, tracts, parcels of land and other property shown upon the assessment roll is determined and declared to be specially benefited by this improvement in at least the amount charged against the same, and the assessment appearing against the same is in proportion to the several assessments appearing upon the roll. There is levied and assessed against each lot, tract or parcel of land and other property appearing upon the roll the amount finally charged against the same thereon.

Section 3. The assessment roll, as approved and confirmed, shall be filed with the Finance Director for collection and the Finance Director is authorized and directed to publish notice as required by law stating that the roll is in his/her hands for collection and that payment of any assessment thereon or any portion of such assessment can be made at any time within 30 days from the date of first publication of such notice without penalty, interest or cost, and that thereafter the sum remaining unpaid may be paid in 15 equal annual installments of principal and interest. The estimated interest rate is stated to be 3.5% per annum, with the exact interest rate to be fixed in the ordinance authorizing the issuance and sale of the local improvement bonds or other financing for Local Improvement District No. 197. The first installment of assessments on the assessment roll shall become due and payable during the 30-day period succeeding the date one year after the date of first publication by the Finance Director of notice that the assessment roll is in his/her hands for collection and annually thereafter each succeeding installment shall become due and payable in like manner. If the whole or any portion of the assessment remains unpaid after the first 30-day period, interest upon the whole unpaid sum shall be charged at the rate as determined above, and each year thereafter one of the installments of principal and interest, together with interest due on the unpaid balance, shall be collected. Any installment not paid prior to expiration of the 30-day period during which such installment is due and payable shall thereupon become delinquent. Each delinquent installment shall be subject to a penalty charge in an amount equal to the bond or installment note interest rate plus five percent (5%), levied upon both principal and interest due on each installment. The collection of such delinquent installments shall be enforced in the manner provided by law.

<u>Section 4</u>. This ordinance shall take effect the day following its publication in the official newspaper of the City of Richland.

Give first reading, by title only, to Ordinance No. 40-16, amending the 2016 budget for Equipment Replacement and Wastewater funds.

Summary:

The 2016 budget for the Equipment Replacement fund included \$400,000 for replacement of a specialized pipeline cleaning vehicle, or vactor truck, for the Wastewater Utility. Staff prepared specifications and solicited competitive bids for the vactor truck in accordance with City purchasing policies. The selected supplier's bid is for \$470,977.57, including sales tax. Staff proposes to add \$75,000 to the Equipment Replacement Fund budget to cover the cost of the vehicle and provide a small margin for ancillary tools.

The budget for the Wastewater Fund included \$94,000 for repair of mechanical equipment at the Wastewater Treatment Facility. This budget value was based on recent years' experience with equipment repair needs. Earlier in 2016, several significant pieces of equipment required repairs at a cost of \$105,000. The specific equipment included a hot-water boiler, two air blowers, and fine bubble diffusers. Each of these pieces of equipment is essential to the correct functioning of the Wastewater Treatment Plant. Repairs to these important pieces of equipment could not be deferred to a future budget cycle. Staff is experiencing the anticipated level of more routine repair needs, so the \$105,000 represents additional costs over and above the budgeted needs.

Staff will be evaluating the appropriate budget level for this category of expenses in preparation of future budgets. Staff is also planning for the deployment of a more robust asset management system and maintenance management system as part of the Enterprise Resource Program initiative currently underway. Improved tools are recommended to manage the complex and valuable inventory of equipment assets for the wastewater and water utilities.

Fiscal Impact:	The proposed ordinance will increase appropriations in the Equipment Replacement Fund by \$75,000 for purchase of a vactor truck. The Wastewater Utility Fund will also be increased by \$105,000 to fund unanticipated repairs. These increases, totaling \$180,000, will come
	from unrestricted ending fund balance in the Wastewater fund which had balance on December 31, 2015 of \$2,662,905.

ORDINANCE NO. 40-16

AN ORDINANCE of the City of Richland amending the 2016 Budget to provide for additional appropriations in the City's Equipment Replacement and Wastewater Funds and declaring that a public emergency exists in the City's Wastewater Fund.

WHEREAS, on November 17, 2015, Richland City Council approved Ordinance No. 74-15 approving the 2016 Budget, including the 2016–2030 Capital Improvement Plan (CIP); and

WHEREAS, the Wastewater Utility Fund currently holds sufficient reserve funds to allow for a transfer of funds to the Equipment Replacement Fund for completion of the vactor truck purchase and the necessary equipment repairs at the Wastewater Treatment Facility; and

WHEREAS, a public hearing was held pursuant to RCW 35.33.091 on August 2, 2016, regarding the increase in appropriations from beginning fund balance in the Wastewater Utility Fund

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Richland as follows:

<u>Section 1</u>. Facts Constituting Emergency. The expenses contained within this ordinance were not anticipated when the 2016 budget was approved.

<u>Section 2</u>. Declaration of Public Emergency. Due to circumstances described above, the City Council declares that a public emergency exists in the Wastewater Fund.

ORDINANCE NO. 41-16

AN ORDINANCE of the City of Richland amending Richland Municipal Code Titles 12 and 22, providing for the deferred payment of impact fees required for single family residences.

WHEREAS, Senate Bill 5923 adopted by the Washington State Legislature in 2015 mandates that cities and counties collecting impact fees provide a mechanism to collect those fees at the completion of the construction process; and

WHEREAS, under its existing code provisions, the Richland Municipal Code (RMC) requires payment of traffic impact fees under the provisions of Chapter 12.03 and requires the payment of park mitigation fees under the provisions of Chapter 22.12, calling for those fees to be paid at the time a building permit is issued for a project; and

WHEREAS, on June 22, 2016, the Planning Commission held a legally advertised public hearing to formally consider amendments to RMC Sections 12.03.080, 12.03.085 and 22.12.030 and has unanimously recommended approval of the proposed code amendments.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Richland as follows:

Section 1. RMC Chapter 12.03, ROAD IMPACT FEES, shall be amended to read as follows:

12.03.010 Authority and purpose.

The South Richland traffic impact fee program has been developed pursuant to the city of Richland police powers, the Growth Management Act as codified in Chapter 36.70A RCW, the enabling authority in Chapter 82.02 RCW, Chapter 58.17 RCW relating to platting and subdivisions and the State Environmental Policy Act (SEPA), Chapter 43.21C RCW.

The purpose of the traffic impact fee program is to:

A. Develop a program consistent with Richland's comprehensive plan, the six-year transportation improvement program (TIP) and the capital facilities plan (CFP), for joint public and private financing of transportation improvements necessitated in whole or in part by development within the program boundary;

B. Ensure adequate levels of transportation and traffic service consistent with the level of transportation service identified in the comprehensive plan and this title;

C. Create a mechanism to charge and collect fees to ensure that all new development bears its proportionate share of the capital costs of off-site transportation facilities directly necessitated by new development; and

D. Ensure fair collection and administration of such transportation impact fees.

The provisions of the South Richland traffic impact fee program shall be liberally construed to effectively carry out its purpose in the interests of the public health, safety and welfare. [Ord. 39-04; Ord. 03-09].

12.03.020 Definitions.

"Developer" means an individual, group of individuals, partnership, corporation, association, municipal corporation, state agency, or other person undertaking development and their successors and assigns.

"Development" means the subdivision or short platting of land or the construction or expansion of commercial, industrial, public, or any other nonresidential building, building space, or land that generates additional vehicular trips.

"Development permit" means a building permit, special use or other city-issued permit required to develop property that will generate additional vehicular trips.

"Equivalent single-family residential unit" means a unit of development that generates 10 vehicle trips per day as defined by the latest edition of the ITE Trip Generation Manual.

"Fair market value" means the price that a property will bring in a competitive and open market under all conditions of a fair sale, the buyer and seller each prudently knowledgeable, and assuming the price is not affected by undue stimulus, measured at the time of the dedication to local government of land or improved transportation facilities.

"Off-site transportation improvements" means those transportation capital improvements designated in the comprehensive plan or capital facilities plan adopted by the city that serve the transportation needs of more than one development.

"Traffic impact zone" means an identified traffic shed boundary as depicted on the official plan map with similar travel patterns that will benefit from a group of planned improvement projects.

"Transportation impact fee" means a monetary charge imposed on new development for the purpose of mitigating off-site transportation impacts that are a direct result of the proposed development. [Ord. 39-04; Ord. 03-09].

12.03.030 Imposition of transportation impact fees.

Transportation impact fees imposed in this program:

A. Shall only be imposed for system improvements that are reasonably related to the new development;

B. Shall not exceed a proportionate share of the costs of system improvements that are reasonably related to the new development;

C. May be collected and spent only for system improvements, which are provided for in the transportation element of the capital facilities plan and comprehensive land use plan;

D. Shall not be imposed to mitigate the same off-site transportation facility impacts that are mitigated pursuant to the State Environmental Policy Act (SEPA) or any other law;

E. Shall not be used to correct existing transportation system deficiencies as of the date of adoption of this plan; and

F. Shall be collected only once for each development, unless changes or modifications to the development are proposed which result in greater direct impacts on transportation facilities than were considered when the development was first approved. [Ord. 39-04; Ord. 03-09].

12.03.040 Calculation of impact fees.

The method of calculating the transportation impact fees in this program incorporates, among other things, the following:

A. The cost of public streets and roads necessitated by new development;

B. An adjustment to the costs of the public streets and roadways for past or future SEPA mitigation payments made by previous development to pay for particular system improvements that were prorated to the particular system improvement;

C. The availability of other means of funding public street and roadway improvements; and

D. The methods by which public street and roadway improvements were financed.

Each single-family residence unit in Traffic Impact Zone 1 shall be subject to a fee amounting to \$1,533.56. Each single-family residence unit in Traffic Impact Zone 2 shall be subject to a fee amounting to \$474.57. Fees for commercial, industrial, and/or multifamily developments will be calculated based on their peak hour trip generation rates as determined by the city engineer applying the latest version of the ITE Trip Generation Manual. Pass-by and internally captured trips will be deducted from the total trip generation in determining new development trips. As an example, a commercial building in Traffic Impact Zone 2 generating 150 trips with 50 being pass-by and/or internally captured trips resulting in 100 new peak hour trips will have an impact fee of \$47,457. [Ord. 39-04; Ord. 03-09; Ord. 41-12 § 1].

12.03.060 Credits.

A credit, not to exceed the impact fee otherwise payable, shall be provided for the fair market value of any dedication of land for, improvement to, or new construction of any system improvements provided by the developer, to facilities that are identified in the financing plan. The determination of "value" shall be consistent with the assumptions and methodology used by the city in estimating the capital improvement costs. [Ord. 39-04].

12.03.070 Applicability.

The requirements of the South Richland traffic impact fee program apply to all development activity in the city of Richland as depicted on the map titled Exhibit A that is attached to Ordinance No. 41-12 codified in this section. Unincorporated areas within the boundary will not be used in the fee calculations and once annexed into the city will be assigned to the appropriate fee area and shall participate in the program prior to approval of any development proposal. [Ord. 39-04; Ord. 03-09; Ord. 41-12 § 2].

12.03.080 Time of payment of impact fees.

All new development within the program boundary shall pay a transportation impact fee in accordance with the provisions of this plan at the time that the applicable development permit is ready for issuance; <u>except</u> that permit applications for detached or attached single family residences may defer impact fee payment, as authorized under RMC 12.03.085. The fee paid shall be the amount in effect as of the date of the permit issuance.

The impact fee amount shall be set as of the date of the development permit application. No development permit shall be issued until the impact fee is paid; <u>except as authorized under RMC 12.03.085</u>.

A developer may obtain a preliminary determination of the impact fee before application for a development permit.

Impact fees may be paid under protest in order to obtain a permit or other approval of development activity.

12.03.085 Deferral of impact fee payment.

Impact fees required for a detached or attached single family residence shall be paid either prior to the issuance of a building permit for a single family residence or, if the applicant chooses, the impact fee can be deferred until the time that the city approves the final building inspection for the single family residence. If an applicant chooses to defer payment of an impact fee, the following process shall be followed:

A. The amount of the impact fee shall be determined at the time the applicant applies for deferral of the impact fee.

B. The applicant shall grant a deferred impact fee lien against the property in favor of the City of Richland in the amount of the deferred impact fee. The deferred impact fee lien shall include the legal description of the property, the County Assessor tax parcel number, and the property address on a form approved by the City and containing the signatures of all owners of the property.

C. The deferred impact fee lien shall be recorded by the City. The applicant shall be responsible for providing all recording fees for the deferred impact fee lien.

D. Once the impact fee has been paid, the City shall execute a release of deferred impact fee lien. The applicant shall be responsible for recording the release of deferred impact fee lien.

The City shall not approve the final inspection or issue a certificate of occupancy for any building until the impact fee has been paid in full.

<u>Section 2</u>. RMC Title 22, Section 22.12.030 entitled Payment of fees, shall be amended to read as follows:

22.12.030 Payment of fees.

The department shall not provide a approve the final inspection and issue the Certificate of Oeccupancy permit unless and until the impact fees required by this chapter, less any permitted exemptions, credits or deductions, have been paid in full or land has been dedicated per RMC 12.12.050 or park fee credits have been approved by the city. If the payment of impact fees is deferred past the point of permit issuance, the process for the deferral of impact fee payments as set forth in RMC 12.03.085 shall be followed.

A. Fees shall be deposited in a park reserve fund account as established in RMC 3.24.150 through 3.24.170 and shall be used for the acquisition or improvement of park and recreational facilities serving and primarily benefiting residents of the zone with respect to which such payments have been made.

B. Acquisition and/or improvement of such park and recreation facilities shall be made as sufficient funds become available and consistent with the most recent adopted version of the parks and recreation plan.

<u>Section 3</u>. This ordinance shall be effective immediately following the day after its publication in the official newspaper of the City.

REQUEST: TEXT AMENDMENTS TO SECTIONS 12.03.080 & 22.12.030 23.22.020 AND A NEW SECTION 12.03.085 CONCERNING DEFERRAL OF IMPACT FEES

LOCATION: CITYWIDE

REASON FOR REQUEST:

New state legislation requires cities and counties that collect impact fees to allow for those fees to be deferred until final building inspection, the issuance of a certificate of occupancy or the closing of the first sale of the property.

FINDINGS AND CONCLUSIONS

Staff has drafted text amendments to the traffic impact fee and park mitigation fee sections of the Richland Municipal Code and submits that:

- 1. Senate Bill 5923 was adopted by the Washington State Legislature during the 2015 regular session and is scheduled to take effect statewide as of September 1, 2016. The bill mandates that cities and counties that collect impact fees on new single family dwellings provide a mechanism to collect those fees at either the time of final building inspection, the issuance of a certificate of occupancy or the closing of the first sale of the property;
- 2. Under its existing code, the City of Richland requires the payment of traffic impact fees in accordance with RMC Chapter 12.03 and also requires the payment of park mitigation fees in accordance with RCM Chapter 22.12;
- 3. The existing code provisions require impact fees to be paid at the time of building permit issuance for all traffic impact fees;
- 4. The proposed code amendments would provide for the deferral of traffic and park impact fees for all single family residences to be paid at the time that a final building inspection is requested and require the applicants to grant a deferred

impact fee lien and in so doing meet the requirements established in state law under Senate Bill 5923;

5. Based upon the above findings and conclusions, the adoption of the proposed amendments to Sections 12.03.080, 12.03.085 and 22.12.030 of the Richland Municipal Code providing for a deferral of payment for traffic and park impact fees is in the best interest of the community of Richland.

RECOMMENDATION

Staff recommends the Planning Commission concur with the findings and conclusions set forth in Staff Report (Z2016-103) and recommend to the City Council adoption of the proposed code amendments to RMC Sections 12.03.080, 12.03.085 and 22.12.030.

SUPPLEMENTAL INFORMATION

EXISTING CODE

The current City code relating to payment of impact fees is found in two places within the municipal code. Chapter 12.03 establishes requirements for traffic impact fees, while Chapter 22.12 sets forth standards for park mitigation fees. These code sections currently read as follows:

Section 12.03.080

All new development within the program boundary shall pay a transportation impact fee in accordance with the provisions of this plan at the time that the applicable development permit is ready for issuance. The fee paid shall be the amount in effect as of the date of the permit issuance.

The impact fee amount shall be set as of the date of the development permit application. No development permit shall be issued until the impact fee is paid.

A developer may obtain a preliminary determination of the impact fee before application for a development permit.

Impact fees may be paid under protest in order to obtain a permit or other approval of development activity.

Section 22.12.030

The department shall not provide a final inspection and occupancy permit unless and until the impact fees required by this chapter, less any permitted exemptions, credits or deductions, have been paid in full or land has been dedicated per RMC 12.12.050 or park fee credits have been approved by the city.

- A. Fees shall be deposited in a park reserve fund account as established in RMC 3.24.150 through 3.24.170 and shall be used for the acquisition or improvement of park and recreational facilities serving and primarily benefiting residents of the zone with respect to which such payments have been made.
- B. Acquisition and/or improvement of such park and recreation facilities shall be made as sufficient funds become available and consistent with the most recent adopted version of the parks and recreation plan.

REVIEW OF STATE REQUIREMENTS

While the new state law mandates that impact fee deferrals be granted for single family residences, the law provides cities with some latitude in how those deferrals are granted. Deferred impact fees must be paid at one of three points in the process: at final building inspection; at the issuance of a certificate of occupancy; or at the closing of the first sale of the property.

At a minimum the state law requires deferrals to be granted for the first 20 single family residential building permits issued within a year. It also requires that any individual taking advantage of the deferred fee must also grant a deferred impact fee lien, which is to be recorded with the County Auditor. Once the impact fees have been paid, cities are obligated to issue a release of the deferred impact fee lien.

PROPOSED CODE CHANGES

Staff is recommending that the impact fees be deferred until the time of final building inspection. From an administrative standpoint, this is the easiest point in the process to collect the deferred fees, better than either the sale of the home or issuance of a certificate of occupancy. The proposed code amendments do not attempt to limit the number of deferrals that can be granted in one year. Again from an administrative standpoint, it would be easier offer the deferral to all applicants, rather than try to track the number of deferral granted. As required under the new law, the proposed code amendments requires the applicant to sign a deferred impact fee lien.

SUMMARY

The proposed code amendments would implement the provisions of Senate Bill 5923 in such a way as to provide home builders with the option to defer impact fee payments with the least amount of administrative process changes.

Summary:

The 2016 budget for the Solid Waste Fund included \$50,000 in the Capital Improvement Plan for a new monitoring well at the landfill. The budget was recommended on the basis of dialog with Washington State Department of Ecology staff regulating the groundwater contamination issue at the landfill. As staff began implementing this item, further dialog with Ecology led to consideration of the potential benefits of an Agreed Order process. The primary benefit to the Agreed Order process will be enhanced eligibility for cost recovery from a State grant funding program. Additionally, staff became aware of the potential for insurance coverage toward the costs of groundwater contamination management. These new avenues of addressing the issue have required more professional services, including legal counsel, than was originally budgeted. Staff recommends increasing the 2016 budget by \$50,000 to cover the additional professional services needed to negotiate the Agreed Order and initiate the insurance recovery process.

Fiscal Impact:	The proposed budget increase will provide \$50,000 in additional appropriations, drawn from a
	net position in the Solid Waste Fund of \$342,701.

Give second reading and pass Ordinance No. 37-16, amending Title 5: Licensing and Taxation of the Richland Municipal Code.

Summary:

The City has need, from time to time, to amend the Richland Municipal Code (RMC) to bring the code into alignment with applicable state law, to eliminate or clarify ambiguity, or to align with current practices. Proposed Ordinance 37-16 is a house-keeping ordinance designed to fix two ambiguities in RMC Title 5.

Currently, existing RMC 5.20.100 imposes a city utility tax on everyone, including the city, engaged in or carrying on the business of selling or furnishing electric power, a fee or tax equal to eight and one-half percent (8.5%) of the gross electric revenues of the business during the tax year for which a business license is required. RMC 5.20.100 deviates from the rest of RMC 5.20 in that it refers to "gross electric revenues" as opposed to "gross income," a term that is defined in RMC 5.20.020. RMC 5.20.020 does not provide a definition of "gross electric revenues," but the term is well-defined under state law. Therefore, in order to eliminate ambiguity, and to clarify the taxing requirements as they relate to the business of selling or furnishing electric power, it is appropriate to amend the RMC to define "gross electric revenues." The definition proposed is consistent with the way Benton PUD and Richland Energy Services are currently remitting utility tax to the City's general fund, and will result in no change to existing practices.

The other change requested is a similar house-keeping effort. RMC 5.20.105 imposes a 1% utility tax on the City's ambulance utility. The code provides that the tax will be assessed on the utility's "gross revenues." RMC 5.20.020 has no definition of "gross revenues" but does define "gross income," which is the basis for calculating utility tax on all the other utilities (except electric, as discussed above). Amending the language from "gross revenue" to "gross income" is appropriate to bring code and current practice into alignment. No change to exsisting practices will result.

ORDINANCE NO. 37-16

AN ORDINANCE of the City of Richland Amending Title 5: Licensing and Taxation of the Richland Municipal Code regarding Definitions and the Ambulance Utility Occupation Tax.

WHEREAS, the City of Richland has need, from time to time, to amend the Richland Municipal Code (RMC) to bring the code into alignment with applicable state law, to eliminate or clarify ambiguity, or to align with current practices; and

WHEREAS, RMC 5.20.100 imposes a city utility tax on everyone, including the city, engaged in or carrying on the business of selling or furnishing electric power, a fee or tax equal, effective November 1, 1996, to eight and one-half percent (8.5%) of the gross electric revenues of the business during the tax year for which a business license is required; and

WHEREAS, RMC 5.20.100 deviates from the rest of the provisions contained in RMC 5.20 in that it refers to "gross electric revenues" as opposed to "gross income," a term that is defined in RMC 5.20.020; and

WHEREAS, RMC 5.20.020 does not currently contain a definition of "gross electric revenues," but the term is well-defined under state law; and

WHEREAS, in order to eliminate ambiguity, and to clarify the taxing requirements as they relate to the business of selling or furnishing electric power, it is appropriate to amend the RMC to define "gross electric revenues"; and

WHEREAS, RMC 5.20.105 imposes a 1% utility tax on ambulance services performed by the City; and

WHEREAS, RMC 5.20.105 deviates from the rest of the provisions contained in RMC 5.20 in that it refers to "gross revenues" of the utility as opposed to "gross income"; and

WHEREAS, RMC 5.20.020 does not currently define "gross revenues," but the code does provide a definition for "gross income," which is the basis from which all of the other utilities are taxed, with the exception of the electric utility; and

WHEREAS, in order to eliminate ambiguity and to bring the language of the Richland Municipal Code into alignment with the City's practices related to collecting utility tax, it is appropriate to amend RMC 5.20.105 to reflect "gross income" as opposed to "gross revenue."

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Richland as follows:

<u>Section 1</u>. Richland Municipal Code Section 5.20.020, entitled Definitions, as enacted by Ordinance No. 117, and last amended by Ordinance No. 50-04, is hereby amended to read as follows:

5.20.020 Definitions.

In construing the provisions of this chapter, save when otherwise plainly declared or clearly apparent from the context, the following definitions shall be applied:

"City" means the city of Richland, Washington.

"Finance manager" means the finance manager of the city of Richland.

"Gross electric revenues" means the amount received from the sale of electric energy, which also includes any regularly recurring charge billed to consumers as a condition of receiving electric energy.

"Gross income" means the value proceeding or accruing from the sale of tangible property or of service, and receipts (including all sums earned or charged, whether received or not), by reason of the investment of capital in the business engaged in, including rentals, royalties, fees or other emoluments, however designated (excluding receipts or proceeds from the use or sale of real property or any interest therein, and proceeds from the sale of notes, bonds, mortgages, or other evidences of indebtedness, or stocks and the like and excluding receipts or proceeds from federal, state or local grants, or contributions in aid of construction), and without any deduction on account of the cost of the property sold, the cost of materials used, labor costs, interest or discount paid, or any expense whatsoever, and without any deduction on account of losses.

"Person" or "persons" means persons of either sex, firms, co-partnerships, corporations and other associations of natural persons, whether acting by themselves or by servants, agents or employees.

"Taxpayer" means any person liable for the license fee or tax imposed by this chapter.

"Tax year" or "taxable year" means the year commencing January 1st and ending December 31st of the same year, or in lieu thereof, the taxpayer's fiscal year when permission is obtained from the finance manager to use the same as the tax period.

<u>Section 2</u>. Richland Municipal Code Section 5.20.105, entitled Occupation subject to tax – Ambulance utility – Amount, as enacted by Ordinance No. 50-04, and subsequently amended by Ordinance No. 18-08, is hereby amended to read as follows:

5.20.105 Occupation subject to tax – Ambulance utility – Amount.

There is hereby levied upon and shall be collected from the city, engaged in the business of furnishing ambulance services, a fee or tax equal to one percent of the gross <u>income</u>

revenues of the utility during the tax year for which a license is required to be effective September 1, 2006.

<u>Section 3</u>. This ordinance shall take effect the day following its publication in the official newspaper of the City of Richland.

Summary:

The City of Richland entered into a Power Sales Agreement (PSA) with Bonneville Power Administration (BPA), BPA Contract No. 09PB-13097, in 2009 stipulating the conditions for wholesale power sales from BPA to the City through September, 2028. A condition of the PSA is that the City will declare the amounts for non-federal power it agrees to secure in whole amounts of average megawatts (aMW) each fiscal year within four separate PSA purchase periods. The deadline for this PSA condition for the third purchase period (2020 through 2024) is due September 30, 2016.

The City's Energy Services Department (RES) staff have developed a policy framework related to this decision, and have reviewed that framework with the City's Utility Advisory Committee (UAC) over several UAC regular and special committee meetings during the last half of 2015 and the first half of 2016. As a result of these efforts, the UAC officially endorsed a final RES policy recommendation to declare whole power amounts equaling fifty percent (50%) of each fiscal year's load forecast for the third purchase period as non-federal power which the City intends to secure.

RES staff recommends adoption of Resolution No. 140-16 authorizing the City Manager or designee to calculate and then notify BPA of the City's intention to secure non-federal power based on fifty-percent (50%) of each fiscal year's load forecast for the PSA third purchase period being years 2020 through 2024. There will be no immediate fiscal impact related to current budget as a result of this decision. Impacts for future years related to this decision will be addressed in the electric utility's forward rate program model.

RESOLUTION NO. 140-16

A RESOLUTION of the City of Richland authorizing the City Manager or designee to designate the amount of nonfederal power purchases for fiscal years 2020 through 2024.

WHEREAS, the City of Richland entered into a Power Sales Agreement (PSA) with Bonneville Power Administration (BPA), BPA Contract No. 09PB-13097, in 2009 stipulating the conditions for wholesale power sales from BPA to the City through September, 2028; and

WHEREAS, a condition of the PSA is that the City will declare the amounts for non-federal power it agrees to secure in whole amounts of average megawatts (aMW) each fiscal year within four separate PSA purchase periods; and

WHEREAS, the City has met this PSA condition for the first purchase period (2011 through 2014) and for the second purchase period (2015 through 2019); and

WHEREAS, the deadline for this PSA condition for the third purchase period (2020 through 2024) is due September 30, 2016; and

WHEREAS, the City's Energy Services Department (RES) staff has worked with representatives from Northwest Energy Management Services (NEMS) to prepare a policy framework for this decision based on the best balance of fiscal strength with future power market risk; and

WHEREAS, RES staff has reviewed this policy framework with the City's Utility Advisory Committee (UAC) over several UAC regular and special committee meetings during the last half of 2015 and the first half of 2016; and

WHEREAS, at a regular UAC meeting on July 5, 2016, the UAC officially endorsed a final RES policy recommendation to declare whole power amounts equaling fifty percent (50%) of each fiscal year's load forecast for the third purchase period as non-federal power which the City intends to secure.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Richland, that the Richland City Council authorizes the City Manager or designee to calculate and then notify BPA of the City's intention to secure non-federal power based on fifty-percent (50%) of each fiscal year's load forecast for the PSA third purchase period.

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.

Approve Resolution No. 145-16, repealing Resolution No. 214-15 and authorizing a South Richland Collector Street Latecomer Agreement with Anderson Heights Development, LLC.

Summary:

The Anderson Heights subdivision is located south of Westcliffe Boulevard, west of Brantingham Street, and north and east of the Kennewick Irrigation District canal. The subdivision included the planned extension of Gala Way and Melissa Street, segments in the South Richland Collector Street plan. Pursuant to Richland Municipal Code (RMC) Section 12.03 and the preliminary plat conditions for the subdivision, the developer completed construction of these planned streets. The documented actual costs for these streets exceeded the value of impact fees to be collected from building lots in the subdivision. Pursuant to RMC Section 12.03 the developer is eligible for a latecomer agreement to recoup eligible costs from the impact fee revenue.

At its December 1, 2015 meeting, Council approved Resolution No. 214-15, authorizing a latecomer agreement with the Anderson Heights developer. Subsequent to Council's action, the developer sought to renegotiate the terms of the agreement. City staff agreed that renegotiation was reasonable and negotiated an agreement with terms that will accelerate reimbursement of the developer's costs while maintaining the viability of the City's impact fee fund. The developer has indicated acceptance of the renegotiated terms.

Staff recommends approval of Resolution No. 145-16, which will repeal Resolution No. 214-15 and authorize execution of the renegotiated latecomer agreement.

Fiscal Impact: The latecomer agreement requires payment by the City of \$31,903.81 within 30 days of agreement execution. It also requires quarterly payments of six percent (6%) of revenue collected in Zone I of the South Richland Collector Street Fund. The current available balance in Zone I Traffic Impact Fee revenue is \$311,048.55. A budget adjustment will be required to appropriate the funds once the agreement is approved.

WHEREAS, the City wishes to provide the reimbursement sought by Anderson Heights Development, LLC as part of its strategy to promote construction of streets in the South Richland Collector Street Plan; and

WHEREAS, Chapter 35.72 of the Revised Code of Washington (RCW) authorizes the City to contract for construction of streets required to service development; and

WHEREAS, on December 1, 2015, Richland City Council approved Resolution No. 214-15, authorizing execution of a South Richland Collector Street Latecomer Agreement with Anderson Heights Development, LLC ("Initial Agreement"); and

WHEREAS, additional terms were negotiated by the parties subsequent to Council's approval of the proposed Initial Agreement, all of which are consistent with state law and the Richland Municipal Code; and

WHEREAS, repeal of Resolution No. 214-15 is appropriate since the Initial Agreement was never executed by either party, and Council approval is now sought on the renegotiated South Richland Collector Street Latecomer Agreement with Anderson Heights Development, LLC.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Richland that Resolution No. 214-15 is hereby repealed, and the City Manager is hereby authorized to sign and execute the renegotiated South Richland Collector Street Latecomer Agreement with Anderson Heights Development, LLC.

SOUTH RICHLAND COLLECTOR STREET LATECOMER AGREEMENT

This Agreement made this ____ day of _____, 2016 between the City of Richland, Washington, a municipal corporation, hereinafter called the "City" and Anderson Heights Development, LLC, hereinafter called the "Developer."

WHEREAS, Section 12.03 of the Richland Municipal Code establishes the South Richland Collector Street Financing Plan; and

WHEREAS, the South Richland Collector Street Financing Plan establishes a street assessment reimbursement area; and

WHEREAS, property development projects within the street assessment reimbursement area are required to construct the planned street improvements as a condition of development; and

WHEREAS, property development projects within the street assessment reimbursement area jointly finance right-of-way acquisition, design engineering, and construction of street improvements through collection and expenditure of a development impact fee; and

WHEREAS, the City has approved the Developer's proposed development, the preliminary plat of "Anderson Heights" within the South Richland collector street assessment reimbursement area; and

WHEREAS, the Developer's proposed development includes the right-of-way for Gala Way, an arterial collector street as defined within the South Richland Collector Street Financing Plan; and

WHEREAS, the City-approved conditions for the Developer's project includes the requirement to dedicate right-of-way, provide a design, and construct street improvements within the dedicated right-of-way; and

WHEREAS, Section 12.03 of the Richland Municipal Code authorizes expenditure of collected impact fees to acquire right-of-way, and to finance the design and construction of arterial collector streets; and

WHEREAS, the Developer has provided, and the City Engineer has reviewed and approved, estimates of the cost of the Gala Way right-of-way, street construction and design fees for the streets required within the Developer's projects. The City Engineer has determined that these costs exceed the traffic impact fee obligation for the Developer's projects; and

WHEREAS, the Developer wishes to be reimbursed for costs in excess of the project's South Richland Collector Street Financing Plan fee obligation; and

WHEREAS, the City wishes to provide the reimbursement sought by the Developer as part of its strategy to promote construction of streets in the South Richland Collector Street Plan; and

WHEREAS, Chapter 35.72 of the Revised Code of Washington authorizes the City to contract for construction of streets required to service development.

NOW THEREFORE, in consideration of the construction of a portion of Gala Way within the South Richland Collector Street assessment reimbursement area, and the Developer's dedicating said street as a part of the City's South Richland collector street system, along with other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. Arterial Collector Street - Acceptance by City:

The City has approved construction of that portion of Gala Way, approximately 960 linear feet in length, lying within the Anderson Heights subdivision. The City has accepted this street facility as a City street. After the construction warranty has expired, the City agrees to bear all further maintenance and operation costs of said street.

2. Cost of Streets:

The Developer has presented to the City Engineer documentation showing the right-ofway and construction costs of said street, and the City Engineer has reviewed the documents submitted. The parties agree that the total cost of said street is \$127,815.87, consisting of the following:

Gala Way Right-of-Way	\$ 52,800.00
Gala Way Construction	<u>\$ 75,015.87</u>
Total Construction cost	\$127,815.87

The final plat of Lexington Heights Phase 5 (the final phase of Anderson Heights) contained 14 lots. According to section 12.03 of the Richland Municipal Code the traffic impact fees for each of these lots would be \$1,533.56. The credit is therefore adjusted as follows:

\$1,533.56 X 14 = \$21,469.84 \$127,815.87 - 21,469.84 = \$**106,346.03**

3. Payments required:

The City hereby agrees that these street improvements will benefit properties within the street assessment reimbursement area defined in the South Richland Collector Street Financing Plan. Future developments within the street assessment reimbursement area

shall pay a fair prorated share of the Developer's costs through payment of the traffic impact fee.

4. Repayment:

The City agrees to reimburse the Developer as follows:

- The City will pay the Developer \$31,903.81 within 30 days of execution of this Agreement
- The City will pay the developer 6% of the traffic impact fee revenue from the South Richland Collector Street Fund collected in Zone 1 beginning December 31, 2015. Payments will be made on or before the last day of each quarter (i.e. March 31, June 30, September 30, and December 31). Payments will commence with the quarter following the date of execution of this Agreement; the first payment shall include retroactive payments for the quarters ending December 31, 2015, March 31, 2016 and June 30, 2016
- After City Council approval of any future final plat completed by the Developer within the impact fee area, the Developer may direct, in writing, the City to credit the South Richland Collector Street Impact fees for that plat to the outstanding balance of this Agreement. This right is not transferrable or assignable unless such assignment or transfer is granted in writing by the City.
- Total payments to the Developer from the South Richland Collector Street Fund, as identified in the aforementioned Item 2. Cost of Streets, will not exceed \$106,346.03, EXCEPT as increased by annual adjustments, applied on June 30, for inflation of 3% which shall be added annually to the then unpaid balance owing the Developer by the City. The first year of this 3% inflation, based on the unpaid balance as of June 30, 2016, shall be for the period starting December 31, 2015 through June 30, 2016, resulting in an beginning unpaid balance, as of June 30, 2016 of \$107,941.22. The City shall, on June 30, 2017 and each year thereafter on June 30, increase the then unpaid balance by 3%.
- 5. Term:

This Agreement shall continue in force and effect for a maximum of fifteen (15)) years from the date this Agreement is executed, or until the balance owed is paid in full, whichever occurs first.

6. Pursuant to RCW 35.72.020(3), every two (2) years from the date of execution of this Agreement, Developer or any assign who is entitled to recover under this Agreement shall notify the City of the current contract name, address and telephone number of the person, company or partnership that originally entered into this contract. Such notice must be received by the City within sixty (60) days of the time specified in this Section, and shall be directed as follows:

City of Richland Attn: Public Works Director P.O. Box 190 Richland, WA 99352 Failure to comply with this notice requirement shall result in the City retaining any reimbursement funds owed to the property owner under this Agreement.

7. Recording:

This Agreement shall not be enforceable against any party unless Developer has caused the same to be filed and recorded with the Benton County Auditor.

8. Governing Law/Forum Selection:

The interpretation and enforcement of this Agreement shall be governed by the laws of the state of Washington. The Parties agree that Benton County is the appropriate venue for the filing of any civil action arising out of this Agreement.

9. Severability:

In the event that any term or condition of this Agreement or application thereof to any person, entity, or circumstance is held invalid, such invalidity shall not affect any other terms, conditions, or applications of this Agreement which can be given effect without the invalid term, condition, or application. To this end, the terms and conditions of this Agreement are declared severable.

Summary:

The Westcliffe subdivision is located south and west of the Kennewick Irrigation District canal, generally between Gala Way and Queensgate Drive. The subdivision included the planned extension of Queensgate Drive, a segment in the South Richland Collector Street plan. The Westcliffe preliminary plat was approved before adoption of Richland Municipal Code Section (RMC) 12.03, the South Richland Collector Street Impact Fee program. The Westcliffe preliminary plat is not conditioned to require compliance with the construction standards for Queensgate Drive that were implemented with RMC 12.03. The developer has voluntarily redesigned his preliminary plat to conform to the City's design standards for Queensgate Drive. The costs of constructing Queensgate Drive within Westcliffe have exceeded the value of impact fees available from building lots in the subdivision. Pursuant to RMC Section 12.03, the developer is eligible for a latecomer agreement to recoup eligible costs from the impact fee revenue.

City staff and the developer have negotiated the terms of the proposed latecomer agreement. The terms are substantially the same as the terms negotiated with another recent latecomer agreement, but vary to acknowledge the fact that the preliminary plat conditions did not require Queensgate Drive to be designed to arterial collector standards. The major impact of these standards is that the development must be designed with no residential driveways onto Queensgate, thus consuming more developable property for roads than the original subdivision plan.

Staff recommends approval of Resolution No. 146-16. The developer has indicated his acceptance of the negotiated terms.

SOUTH RICHLAND COLLECTOR STREET LATECOMER AGREEMENT

This Agreement is made this ____ day of _____, 2016 between the **City of Richland**, a municipal corporation and City of the First Class ("the City"), 505 Swift Blvd., Richland, WA 99352, and **Westcliffe, LLC**, a Washington limited liability company, 605 Summit Street, Richland, WA 99352 ("Developer").

WHEREAS, Section 12.03 of the Richland Municipal Code establishes the South Richland Collector Street Financing Plan; and

WHEREAS, the South Richland Collector Street Financing Plan establishes a street assessment reimbursement area; and

WHEREAS, property development projects within the street assessment reimbursement area are typically required, as a provision of the City's preliminary plat approval, to construct the planned street improvements as a condition of development; and

WHEREAS, property development projects within the street assessment reimbursement area jointly finance right-of-way acquisition, design engineering, and construction of street improvements through collection and expenditure of a development impact fee; and

WHEREAS, the City approved Developer's proposed development, the preliminary plat of Westcliffe, in 1994. The City's preliminary plat approval conditions did not require construction of Queensgate Drive to the current arterial collector standards; and

WHEREAS, the preliminary plat of Westcliffe was updated and approved in 2002. The updated conditions of approval for the preliminary plat did not require construction of Queensgate Drive to current arterial collector standards; and

WHEREAS, in 2004, the City adopted Section 12.03 of the Richland Municipal Code. The program did not include the segment of Queensgate Drive within Westcliffe as a designated arterial collector street, and did not include funding for this street segment in the fee program; and

WHEREAS, the City updated Section 12.03 of the Richland Municipal Code in 2009, which revision caused the code to apply to and include the segment of Queensgate Drive within the Westcliffe subdivision; and

WHEREAS, Developer's proposed development includes the right-of-way for Queensgate Drive, an arterial collector street as defined within the South Richland Collector Street Financing Plan; and

WHEREAS, the City-approved conditions for Developer's project do not include the requirement to dedicate right-of-way, provide design, and construct Queensgate Drive as an arterial collector street to the south boundary of the subdivision because the preliminary plat was approved prior to the City including Queensgate Drive as an arterial collector south of the Kennewick Irrigation District canal; and

WHEREAS, Developer has voluntarily revised his subdivision design to include Queensgate Drive as an arterial collector meeting the City's design and access requirements. This voluntary design change to the Westcliffe subdivision, which is desirable to the City, has resulted in a reduction in developable lots as the property needed for Queensgate Drive right-of-way and the access limitations on its design reduce the marketable property within the subdivision; and

WHEREAS, Section 12.03 of the Richland Municipal Code authorizes expenditure of collected impact fees to acquire right-of-way, and to finance the design and construction of arterial collector streets; and

WHEREAS, Developer has provided, and the City Engineer has reviewed and approved, estimates of the cost of the Queensgate Drive right-of-way, embankment construction, retaining wall, design fees and a portion of the asphalt paving for the roadway within Developer's project. The City Engineer has determined that these costs exceed the traffic impact fee obligation for the Developer's projects; and

WHEREAS, the City and Developer obtained separate land appraisals, prepared by thirdparty independent professional land appraisers, for the property to be dedicated as right-of-way for Queensgate Drive. City staff and Developer reviewed both appraisals and have negotiated a compromise on the land valuation portion of the project costs. The compromise value takes into consideration the fact that design and construction of Queensgate Drive to the City's arterial collector standard was not a development condition of Westcliffe, and that the property acquired for Queensgate Drive right-of-way has marketable value as single family lots; and

WHEREAS, Developer wishes to be reimbursed for the costs of constructing a portion of Queensgate Drive that is in excess of the project's South Richland Collector Street Financing Plan fee obligation; and

WHEREAS, the City wishes to provide the reimbursement sought by Developer as part of its strategy to promote construction of collector streets in the South Richland Collector Street Plan; and

WHEREAS, Chapter 35.72 of the Revised Code of Washington authorizes the City to contract for construction of streets required to service development, and to enter into latecomer reimbursement agreements.

NOW THEREFORE, in consideration of the construction of a portion of Queensgate Drive within the South Richland Collector Street assessment reimbursement area, and Developer's constructing and dedicating said street as a part of the City's South Richland collector street system, along with other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. Arterial Collector Street - Acceptance by City.

The City has approved construction of that portion of Queensgate Drive, approximately 2,075 linear feet in length, lying entirely within the Westcliffe subdivision. This segment of Queensgate Drive represents 5 percent, by length, of the remaining collector streets in the assessment reimbursement area. This segment of Queensgate Drive represents 5.8 percent, by estimated value in the assessment financial model, of the remaining improvements in the assessment reimbursement area. The City has accepted this street facility as a City street. After the construction warranty has expired, the City agrees to bear all further maintenance and operation costs of said street.

2. Cost of Streets.

The Developer has presented to the City Engineer documentation showing the right-ofway and construction costs of said street, and the City Engineer has reviewed the documents submitted.

The City and Developer agree that the total cost of said street, including elements such a curbs, gutters, sidewalks, stormwater conveyance and street lighting, is \$1,377,723.62.

The parties agree that the portion of the above total cost of said street which is reimbursable under the provisions of RMC Title 12.03 is \$874,066.83 consisting of the following:

Queensgate Drive Right-of-Way	\$454,021.00
Queensgate Drive Construction	\$390,459.50
Tax	<u>\$ 17,237.11</u>
Total Construction cost	\$874,066.83

The final plats of Westcliffe phases 14 and 15 contains 28 lots. According to RMC Section 12.03, the traffic impact fees for each of these lots would normally be \$1,533.56. Previous work accounting for past investments by Developer in elements of the South Richland Collector Street system have resulted in Westcliffe lots being assessed a modified fee of \$471.65. The parties agree that lots within phases 14 and 15 will be charged this fee at building permit issuance and the amount owed the developer will be as described in section 4.c below.

3. Payments required.

The City hereby agrees that these street improvements will benefit properties within the street assessment reimbursement area defined in the South Richland Collector Street Financing Plan. Future developments within the street assessment reimbursement area shall pay a fair prorated share of Developer's costs through payment of the traffic impact fee.

4. Repayment.

The City agrees to reimburse Developer as follows:

a. The City will pay, within 30 days of the execution of this Agreement, \$262,220.05 as the initial installment toward reimbursement of Developer's costs. This represents 30% of the value of the Queensgate construction costs.

- b. The City will pay Developer 11.6% of the traffic impact fee revenue from the South Richland Collector Street Fund collected in Zone 1, minus that revenue received from lots within Westcliffe which will continue to pay the impact fee of \$471.65. Payments will be made within 30 days of the end of each calendar quarter, and shall be based on that quarter's revenue. The quarters will end on March 31, June 30, September 30, and December 31.
- c. The City will pay the Developer 100% of all traffic impact fee revenue collected from lots within the Westcliffe preliminary plat. These funds will be paid as part of the quarterly payments described in paragraph 4.b.
- d. After City Council approval of any future final plat completed by Developer within the impact fee area, Developer may direct, in writing, the City to credit the South Richland Collector Street Impact fees for said final future plat to the outstanding balance of this Agreement. This right is not transferrable or assignable unless such assignment or transfer is granted in writing by the City.
- e. Total payments to Developer from the South Richland Collector Street Fund will not exceed \$874,066.83, as adjusted by inflation on the unpaid balance. The City shall, as of June 30 of each year, adjust the unpaid balance upward by 3%.
- f. The reimbursement values provided for in this Section 4. Repayment depart from the City's typical repayment values, and are based on Developer's unique circumstances. Nothing contained herein shall be construed as precedent-setting, nor to require the City to make similar reimbursement values available to any third party or to Developer on any other project, except as specifically provided for in Section 6 of this Agreement.

5. Term.

This Agreement shall continue in force and effect for a maximum of fifteen (15) years from the date this Agreement is executed, or until the balance owed is paid in full, whichever occurs first. Nothing in this Agreement shall be construed to guarantee payment in full to Developer.

6. Incomplete Segments of Queensgate Drive.

The City and Developer agree to work together to complete construction of the following necessary and incomplete segments of Queensgate Drive on or before December 31, 2018. Developer shall be responsible for design and construction of the street segments described below. The City shall be responsible for negotiating and completing amendments to this latecomer agreement on similar terms to those included in this Agreement.

a. An approximately 1,000-foot segment of Queensgate Drive lying within the original boundary of the Westcliffe preliminary plat, between Alla Vista Street and Big Sky Drive, remains unimproved. The right-of-way for this segment is presently not owned by the City or Developer. The City desires that this segment be completed prior to completion of the Westcliffe subdivision. If the City acquires ownership of the Queensgate Drive right-of-way between Alla Vista Street and Big Sky Drive prior to December 31, 2017, Developer shall design and construct the street improvements for this segment on or before December 31, 2018.

- i. The street improvements shall include subgrade, crushed rock, asphalt pavement, curb, gutter, sidewalk, street lighting and storm drainage facilities, and roadside landscaping.
- ii. Upon completion of the street improvements, the City and Developer will negotiate an amendment to this latecomer agreement providing for the reimbursement of Developer's street improvement costs eligible under RMC Title 12.03, except that no valuation for the right-of-way shall be included in the latecomer costs.
- iii. Eligible costs under the contemplated latecomer agreement amendment shall additionally include the costs of curbs, gutters, sidewalk, storm drainage facilities and street lights on the west and south frontage of Queensgate Drive from its intersection with White Bluffs Street to its intersection with Big Sky Drive. The east and north frontage adjacent to phase 7 shall be the Developer's financial responsibility.
- b. An approximately 600 foot segment of Queensgate Drive at the far southeast corner of the Westcliffe preliminary plat property is currently incomplete. Developer shall design and complete this segment to City standards on or before December 31, 2018.
 - i. Upon completion, the City and Developer will negotiate an amendment to this latecomer agreement providing reimbursement of Developer's eligible street improvement costs under RMC Title 12.03.

7. Required Notification.

Pursuant to RCW 35.72.020(3), every two (2) years from the date of execution of this Agreement, Developer or any assign who is entitled to recover under this Agreement shall notify the City of the current contract name, address and telephone number of the person, company or partnership that originally entered into this contract. Such notice must be received by the City within sixty (60) days of the time specified in this Section, and shall be directed as follows:

City of Richland Attn: Public Works Director P.O. Box 190 Richland, WA 99352

Failure to comply with this notice requirement shall result in the City retaining any reimbursement funds owed to the property owner under this Agreement.

8. Recording.

This Agreement shall not be enforceable against any party unless Developer has caused the same to be filed and recorded with the Benton County Auditor.

9. Governing Law/Forum Selection.

The interpretation and enforcement of this Agreement shall be governed by the laws of the state of Washington. The parties agree that Benton County is the appropriate venue for the filing of any civil action arising out of this Agreement. Developer expressly consents to personal jurisdiction in Benton County Superior Court.

10. Severability.

In the event that any term or condition of this Agreement or application thereof to any person, entity, or circumstance is held invalid, such invalidity shall not affect any other terms, conditions, or applications of this Agreement which can be given effect without the invalid term, condition, or application. To this end, the terms and conditions of this Agreement are declared severable.

Summary:

In June 2016, an experienced coatings consultant evaluated Primary Clarifier #2 and Digester Tank #1 at the City's Wastewater Treatment Facility (WWTF). The consultant's recommendation was that these structures need to be recoated to preserve and protect the structures from damaging corrosion. This project will consist of recoating work of these structures and some additional painting and maintenance.

On July 25, 2016, the City opened three bids for the Primary Clarifier #2 and Digester Tank #1 Painting and Surface Maintenance project. The low bid was from Extreme Coatings, Inc. at \$478,376.48. The Engineer's estimate was for \$554,403.00. City staff recommends that the contract be awarded to Extreme Coatings based on their low bid and their previous coatings work, including work done at the City's WWTF.

Fiscal Impact: Total project costs including construction, engineering and contingency is \$541,000. There is currently \$863,076.94 available in the Wastewater Treatment Facility Renewal and Replacement for this maintenance work.
