➔ Recreation Division

This year the Parks and • **Recreation Department** partnered with Kadlec Medical Center in hosting the 3rd Annual Jingle Bell Run. With partnership. this the Jingle Bell Run became an official activity of our Annual Winter Wonderland event. The



Jingle Bell Run consists of a 50-yard and 200-yard run for the children and a 5K run/walk for all participants. The Richland Community Center was the headquarters for the event and the 5K run went from Howard Amon Park to the Columbia Point Marina Park and back. Approximately 500 individuals registered for the event and many dressed up to celebrate the holiday season. Race winners were announced right before the lighting ceremony took place at John Dam Plaza.

- During the month of December, the Richland Community Center upgraded its WIFI system. The upgrade will increase signal strength to include the entire facility.
- Have you ever dreamed of being a railroad engineer? The community had a great opportunity to see trains running in Model HO scale at the Annual Tri-City Railroaders display of a typical Eastern Washington railroad at the RCC last month. These skilled model builders amazed everyone with their precision and attention to detail. The display was open prior to the annual Lighted



Boat parade the evening of December 10 and then again on Saturday, December 11. We're looking forward to seeing them back in 2011!

- The annual Barbershop Holiday Concert was on the evening of Friday, December 10 in the Richland Community Center. The Columbia River Chordsmen performed a mix of holiday songs and songs from vester-year. The Lighted Boat Parade followed, with the boats adding to the excitement and experience!
- The Senior Advocate is working with the cities of Pasco and Kennewick in a partnership to develop mutually sponsored trips for the senior

population. This effort is intended to offer a greater variety of destinations while sharing the load in preparatory work. The expected larger numbers of participants may result in lower cost per individual, while increasing revenue. The first destination is scheduled for February and will go to Wenatchee to see *Stars on Ice.*

- Richland's Inaugural Geocoin Challenge has been a great success. Time is quickly running out; we only have 32 geocoins left! For those who are interested in learning more about Richland, go on a geocaching adventure and earn a free geocoin, entry forms can be found on our city website under Parks and Recreation.
- During the month of December, the PA system at George Prout Pool was cleaned and repaired. The renovated system can now be clearly heard throughout the pool building and on the deck. The PA system is an important safety component.
- Richland Youth basketball enrollment is 80 teams of boys and girls grades 2nd to 6th grade for the 2011 season. Practices began on December 13 and are held at all nine elementary school gyms in Richland and West Richland. Games will be held on Saturdays beginning on January 15 and going for 8 weeks the three Richland School District middle schools.
- The lines were long and the servers scooping frantically at the Root Beer Float Social on December 16th. This event is always well attended as young and old alike impatiently wait for a delicious frothy float. *Guardian Angel Homes* provides the supplies as well as the smiling server.
- The December 21st Pie Social was very well attended. Several special guests from Eagle Assisted Living joined us for lunch and the following pie social. There were many smiling faces enjoying the variety of pies donated by *Richland Rehab/Eagle Assisted Living Facility* and *Riverton Retirement Community*. Many of our card game players come early for this special treat!
- First Night Tri-Cities was held on the Campus of CBC on December 31st. Eight different stages where used to host 50 different acts to entertain families. This year's headline performers where Christina and Ally, 21 and 14 year old sisters who recently finished in the top 10 of the TV talent show "America's Got Talent".
- The Blood Pressure/Blood Sugar Clinic continues to grow in numbers due to the consistent service provided by the *Richland Rehab/Eagle Assisted Living Facility.*
- The Adult Slowbreak Basketball league is scheduled to begin on January 16 at Richland High School Gym. This league is open to adults 28 years of age and older with rules designed to slow the fast break aspect of the game. Games are played on Sundays through March. Twelve teams will participate in the league.

• SR-240 Multi-Purpose Trail, Van Giessen to Stevens – Paving has been completed and the contractor is installing fencing.




• Badger Mountain Park

Keene Road Improvements - In the 2011 Capital Improvement Plan funding has been allocated for a left turn lane on Keene Road at the park entrance

Off-leash Dog Playground – The gravel access road has been removed, the interior of the fenced area has been fine graded, a 12 wide maintenance access gate has been installed and mulch for ground cover is being delivered from the City's Solid waste facility.

- Hanford Legacy Park, Babe Ruth Complex Construction has begun on the restroom/concession building. Construction is expected to be completed in three months.
- Yakima River Pump Station Renovations On November 16th Council awarded the bid to Hurst Construction from Wenatchee. Work began on December 13th.

CITY OF RICHLAND PARKS AND RECREATION COMMISSION November 18, 2010

CALL TO ORDER

Mr. Christensen called the meeting to order at **7:01 pm**, led the Pledge of Allegiance, and introduced the newest Commission member Mathew Smith.

ROLL CALL:

APPROVAL OF AGENDA: The agenda was approved as corrected.

APPROVAL OF MINUTES: The July 8th and October 14th agendas were approved as corrected.

COUNCIL / OTHER COMMISSION LIAISON REPORTS: Council Member Kent reported that Council had been busy working on the 2011 budget, encouraged the commission be engaged in the process, and that \$600,000 was added to park projects. She said that yesterday evening was the first meeting of the Tri-Cities Public Utility District, and that they will be making a recommendation for what kind of regional facility should be located in the Tri-Cities. Richland will be hosting those meetings on the 2nd Wednesday of the month at 5:45pm in the City Managers Conference Room.

RECREATION REPORT: Recreation Manager Strand reported on the annual Fall Carnival held at the Community Center on Friday, October 22. This event attracted a record participation, with over 375 people, who enjoyed the numerous carnival games, maze, bounce house, scavenger hunt, Big Top the Clown, cracker decoration, Bingo, scary storytelling and the infamous haunted hay ride. There was also a costume contest with two delighted winners. Additionally, Strand invited both the Commission and audience to attend this year's Tri-Cities Model Railroaders display at the Richland Community Center on the evening of December 10 and 11, to enjoy the event as-well-as view the annual lighted boat parade.

PETITIONS: Report from the Friends of Badger on hiking activity at the Badger Mountain Centennial Preserve.

PUBLIC COMMENT:

Pauline Piepel, 649 Cherrywood Loop, Richland – Expressed opposition to the tower in Lynnwood Loop Park. It would be a danger. Requested that the proposal not be approved.

William L. Kuhn, 624 Millwood Ct, Richland – Presented a petition with 224 signatures in opposition to the tower in Lynnwood Loop Park.

David M. Merrill, 513 Wagon Court, Richland – A member Lynnwood Loop Pool adjacent to the park. Asked how much power is required to operate the tower, how will the power be brought to the tower, who will pay for it, will the power affect the power to the pool, will the construction cause disturbance pool, will it have aircraft warning lights, how loud will the 60 cycle hum from the transformers be, what are the dangers of a kite string coming in contact with the transmission portion of the cell tower, and how far is it from the top of the tower to the lowest acceptable altitude of a plane coming in for a landing at the Richland Airport?

Mike Atchison, 1123 Country Ridge Dr. – Speaking about 2011 bike and trail projects. He requested that hard surface pathways be provided from the Yakima River SR240 bridge through Chamna to Van Geisen and a trail connection be provided along Queensgate Drive.

Clint Gerkensmeyer, 615 Lynnwood Ct. – Poor location for a tower in Lynnwood Lp. Park. Not in My back yard, other properties would be more suitable.

Michelle Levenite, 637 Lynnwood Loop - Speaking against tower in Lynnwood Loop Park. There are plenty of other locations for the tower..

Mark McAllister, 710 Lynnwood Loop – Asked if there are other parks that have cell phone towers and if this would create a precedence.

Emmett Marx, 606 Millwood Court – Asked if there is criteria for allowing towers in parks. Revenue should not be the only criteria.

Janet J. Rohner, 625 Lynnwood Loop – Opposed to the tower in Lynnwood Park. It would be a liability for the city.

Tom May, 617 Lynnwood Loop – Opposed to tower in Lynnwood Loop Park as it would destry the scenery.

Bernerd Anderson, 2224 Redwood Lane - The park is not suitable for commercial purposes such as a tower.

Kelly Carothers, 527 Saint Street - The tower will detract from the whole idea of the park.

Kim Lloyd, 2228 Redwood Lane -. The tower will be an eyesore. Please leave the park beautiful and green. It is peaceful and quiet. Keep it that way.

Bill Ransch, 613 Lynnwood Court - Move the tower out to Stevens Drive.

Hannah Kuhyn, 624 Millwood Ct. – This seems to be a second instance of inappropriate use of the park. Asked if there is a master plan for the park.

John Mucha, 612 Lynnwood Court - Asked about notification for the meeting.

Beth Carothers, 527 Saint Street – Raised concerns about shadows on the pool. Mark Levenite, 637 Lynnwood Loop - Expressed a problem with the fact that the individual that proposed the tower is on the Planning Commission. Asked if this is the way the City conducts business.

Closed public comment period at 7:39 p.m.

PRESENTATION

Ken Buechler, Columbia Basin BMX provided the final report for their Park Partnership Program project which included new concrete near the starting gate, concrete in front of the concessions, installing fencing obtained from Greater Years Park, moved 400 yards of dirt onto the track and rebuild the track, moved the irrigation system and mounted on 4x4 posts and the announcer's booth was roofed and metal siding was added.

AMENDMENT TO LYNNWOOD LOOP AND FRANKFORT PARKS MASTER PLAN TO ADD CELLULAR COMMUNICATION TOWERS

Planning and Construction Manager Pinard introduced this item. He explained the staff recommendation to amend the master plan for both parks to include communication towers.

There was general discussion regarding impact to park (Lynnwood Loop) and if the tower could be placed in other locations in the park.

Mr. Christensen moved to recommend approval of the amendment to the master plan for **Frankfort Park** to include a communication tower at the location identified in Attachment 1. As a condition of approval it was recommended that the tower shall be painted green.

Motion carried.

Mr. Christensen moved to recommend approval of the amendment to the master plan for **Lynwood Loop Park** to include a communication tower at the location identified in Attachment 2. As a condition of approval it was recommended that the tower shall be painted green.

Motion failed.

RECOMMENDATION TO SURPLUS APPROXIMATELY TWENTY THOUSAND TWO HUNDRED (20,200) SQUARE FEET OF CLAYBELL PARK

Planning and Construction Manager Pinard introduced this item. He explained staff recommendation that approximately twenty thousand two hundred square feet at the south east side of Claybell Park be surplused.

There was general discussion regarding giving up park land.

Mr. Christensen moved to forward a recommendation to Council to approve surplusing approximately twenty thousand two hundred square feet of Claybell Park as identified in Attachment 1.
