MINUTES Richland Parks and Recreation Commission Meeting #11-2012 Richland City Hall – 505 Swift Boulevard – Council Chambers Thursday, December 13, 2012, ~ 7:00 pm

CALL TO ORDER:

Vice Chair Jones called the meeting to order at 7:00 pm.

ATTENDANCE:

Chair Gutierrez, Vice Chair Jones, Commissioners Doran, Katipamula, Beck, Valentino, Bern and Richards were present. Commissioner Maya was absent. Also in attendance were Council Liaison Kent, Parks and Recreation Director Schiessl, and Parks and Recreation Managers Pinard and Strand. Vice Chair Jones welcomed Commissioner Richards.

APPROVAL OF THE AGENDA:

It was agreed to approve the December 13, 2012, agenda as presented.

APPROVAL OF THE NOVEMBER 8, 2012, MINUTES:

Nancy Doran **moved** to approve the November 8, 2012, minutes as presented. Shanta Katipamula **seconded** the motion. Motion carried.

RECREATION REPORT:

Parks and Recreation Manager Laurel Strand reported on the 34th annual Cable Bridge Run on December 22. She added that the Richland Parks and Recreation Staff would be volunteering to help the City of Pasco with the race packet distribution. Also, Columbia Basin College will be the venue for the 2012 1st Night Tri-Cities event where city staff will continue to participate in the production of the event similar to previous years.

PRESENTATIONS:

Pam Bykonen, Clerk to Arts Commission, updated the Commissioners on the new sculpture placement in John Dam Plaza. She noted that the location in the northwest corner had been marked and the concrete poured in anticipated installation by the end of the year.

2. Council Liaison:

Council member Kent noted that at the City Council meeting it was their recommendation to approve Barry Richards as a Parks and Recreation Commissioner and welcomed Mr. Richards. Ms. Kent also complimented on the teamwork and collaboration recognized by City Council between the Arts Commission and Parks and Recreation Commission for the purchase and placement of the new artwork.

NEW BUSINESS:

1. Duportail Street Design and Alignment through Lawless Park

Public Works Director Pete Rogalsky explained that the future alignment of Duportail Street with Wellhouse Loop will impact a portion of the north end of Lawless Park. Mr. Rogalsky indicated that the Public Works Department is seeking input from the Parks and Recreation Commissioners on the project. The input received will contribute to design features consistent with Park Planning objectives and assist Public Works in completing required environmental reviews associated with federal transportation grant funds.

Mr. Rogalsky presented the background information and noted that it's part of the 2005 Citywide Transportation Plan that was adopted by the City Council and incorporated into the City's Comprehensive Plan. Parks and Recreation Commissioners inquired as to the speed limit, potential conflicts with the future disc golf course, signage, pedestrian crossings, and street lights. Mr. Rogalsky responded that there will be street lights, traffic signal and pedestrian crossing at Wellsian Way and Duportail, and the speed limit will be 30 mph. Commissioner Doran asked if the proposed road would impact sagebrush and if the plan included mitigation. Mr. Rogalsky indicated that mitigation measures would be implemented.

Vice Chair Jones suggested that Public Works Department come back to the Parks and Recreation Commission when the design documents are ready for review taking into consideration the details from tonight's meeting.

2. Park District 3 Allocation to Howard Amon Park Tennis Court Project

Mr. Phil Pinard presented the final budget of the Howard Amon Park Tennis Court Project and described the work performed. He further explained that there were several change orders issued due to unforeseen circumstances resulting in budget overruns of \$7,500.00 beyond those approved at the November Parks and Recreation Commission meeting. Mr. Pinard requested that the Parks and Recreation Commission recommend to City Council to authorize expenditure of an additional \$7,500 for a total request of \$42,500 of Park District 3 Funds to the Howard Amon Park Tennis Court project.

Jackie Valentino asked if the proposed funding would jeopardize the development of Drollinger Park. Mr. Joe Schiessl noted that other funding sources are available and would be pursued for Drollinger Park.

Nancy Doran **moved** to recommend that City Council authorize an additional expenditure of \$7,500.00 for a total of \$42,500.00 of Park District 3 Funds to the Howard Amon Park Tennis Court project. Shanta Katipamula **seconded** the motion. Motion carried.

3. Chair and Vice Chair Election

Greg Jones **moved** to nominate Maria Gutierrez as Chair for 2013. Nancy Doran **seconded** the motion. Motion carried.

Jackie Valentino **moved** to nominate Greg Jones as Vice Chair for 2013. Barry Richards **seconded** the motion. Motion carried.

I move that the Parks and Recreation Commission recommend Council authorize the purchase of one acre of property on Little Badger Mountain.


FISCAL IMPACT


The one acre parcel is being purchased for \$20,000 plus additional closing and surveying costs estimated at \$1,500. Funding for this acquisition will be as follows: \$5,000 donation from the Friends of Badger Mountain, \$500 from the Willowbrook Community Association and the balance of an estimated \$16,000 from 2013 Trail Maintenance funding from within the Department's operating budget.

BACKGROUND

This acquisition has been discussed previously with the Commission and the Commission favored pursuing up to 5 acres. Due to budget constraints staff is recommending the purchase of one acre which will provide land to accommodate a suitable trail connection between the Falconcrest Trail and the 16 acres of existing City property (Attachment 2).

The Economic development Committee reviewed this request on December 4 and recommended the acquisition of the one acre parcel.
