MINUTES

Richland Parks and Recreation Commission Meeting #8-2013 Richland City Hall – 505 Swift Boulevard – Council Chambers Thursday, October 10, 2013 ~ 7:00 pm

CALL TO ORDER:

Chair Gutierrez called the meeting to order at 7:00 pm.

ATTENDANCE:

Chair Gutierrez, Vice Chair Jones, Commissioners Doran, Bern, Valentino, and McBurney were present. Commissioner Richards was excused. Also in attendance were Council member Kent, Parks and Recreation Director Schiessl, Parks and Recreation Managers Pinard and Strand and Parks and Facilities Supervisor Sweeney.

APPROVAL OF THE October 10, 2013 AGENDA: Nancy Doran **moved** to approve the October 10, 2013 agenda as presented. Vice Chair Jones **seconded** the motion. Motion carried.

APPROVAL OF THE August 8, 2013, MINUTES:

Vice Chair Greg Jones **moved** to approve the August 8, 2013, minutes as presented. Kit McBurney **seconded** the motion. Motion carried.

COUNCIL LIAISON REPORT:

Council member Kent welcomed the public. Ms. Kent reported at the last council meeting there was a concern from a member of the public regarding cancellation of the Parks and Recreation Commission meeting in September. Ms. Kent announced the approval of acceptance of recommendations for the Stevens Drive Master Plan from the Parks and Recreation Commission and also the acceptance from the Arts Commission for the Tree of Life. Additionally, Council approved the arrangements associated with the park partnership funds with Columbia Center Rotary to purchase a slide for Goethals Park. Council Member Kent also announced that the Bookmark Café lease was approved at the library and encouraged everyone to visit the café.

PARKS AND FACILITIES REPORT:

Parks and Facilities Supervisor, Darrin Sweeney reported updates and progress throughout the City. Mr. Sweeney provided a list of projects the facility crews have been working on which will improve structures and clean up landscaping at the following parks; Stevens Triangle garden area, Horn Rapids play area, Badger Mountain Park playfield, Claybell Park and Leslie Groves Park. Sweeney also mentioned the swim dock has been repaired at the Howard Amon Park and the restrooms located off of Newton Street are also repaired and open again.

RECREATION REPORT:

Parks and Recreation Manager, Laurel Strand reported that the Fall Carnival is scheduled for Friday, October 25, 6:30 p.m. at the Richland Community Center. Secondly Strand mentioned that the Winter E-Activity Guide will be available Monday, November 4. Ms. Strand also noted, the kickoff of Winter Wonderland will begin with the Tree Lighting Ceremony at John Dam Plaza November 30 and Holiday by the River is scheduled for Friday and Saturday, December 13-14.

PRESENTATIONS:

Alison Gjefle, President of Richland Lacrosse Club, presented an overview of the growth lacrosse has experienced over the last few years, creating opportunities for kids to play beginning in elementary all the way up through high school. Alison explained the realignment, growth and impact lacrosse has on Richland parks, and shared ideas which would help preserve field surfaces by rotating practice locations. Ms. Gjefle also mentioned that RLC supports future park development, the expansion of lacrosse in Richland which would create opportunities to host annual jamborees and tournaments in the community.

UNFINISHED BUSINESS:

NEW BUSINESS:

1. Introduction to State Required Update of the Shoreline Master Program

Development Services Manager, Rick Simon presented an update of the Shoreline Master Program in regards to the State Shoreline Management Act. Mr. Simon explained that City is in the process of updating its Shoreline Master Program (SMP). Under the provisions of the Washington State Shoreline Management Act, each city, town and county within the state is required to develop and adopt its own shoreline plan and regulations. Richland first adopted its SMP in 1979 and it has been continuously in effect since then. The Shoreline Management Act includes three basic purposes, which can be summarized as follows:

- 1. Protect the environmental resources of the state's shorelines:
- 2. Promote public access to the shorelines; and
- 3. Give priority to types of land uses that require a location on the shoreline.

These basic purposes have not changed. In 2003 the Washington State Department of Ecology adopted new shoreline guidelines which require all cities and towns to update their SMPs. The State Legislature provided funding for this work and Richland received a state grant in 2012 and so is now in the process of updating its SMP. The City has hired a consultant team, headed by Anchor QEA to lead them through the process of an SMP update. The consultants have been working with the Planning Commission and staff over the past year on this project. Work completed to date includes the development of a draft inventory and characterization report of the City's shorelines, and a draft master program. A restoration plan is currently being developed. The

deadline that the City is operating under is to complete the shoreline update process by June of 2014, with the adoption of the updated shoreline program by the City Council. Now that we have a working draft, the next step is to solicit comment and review from the Parks and Recreation Commission, public agencies and the general public. This public review will take place over the next several months.

2. Allocation of Park District 3 funds to Drollinger Park

Parks and Recreation Manager, Phil Pinard presented the recommendation to authorize expenditure of \$15,000 of Park District 3 Funds to Drollinger Park improvements. Mr. Pinard provided the background of Drollinger Park, which is a 1.5 acre undeveloped Neighborhood Park located in the Tanglewood subdivision located on the west side of the By-pass Highway north of Duportail Street. The 2014 Capital Improvement Program (CIP) allocates \$15,000 for the construction of Drollinger Park. The improvements will include irrigation and turf. Pinard noted that the funding is being requested this year as there is a possibility that there will be time for the parks crew to install a portion or all of the irrigation system. These funds will be used to purchase irrigation supplies and trees and pay for contractor expenses for hydro seeding.

Pinard explained the fiscal impact of this request which will leave approximately \$1,000 in Park District 3. This district accumulates very little in annual revenue from Park Impact Fees as little construction occurs in this district. The existing funds in the district came from the new apartments on Duportail Street.

Vice Chair Jones <u>moved</u> that the Parks and Recreation Commission recommend Council authorize expenditure of \$15,000 of Park District 3 funds to funds improvements to Drollinger Park. Dawn Bern **seconded** the motion. Motion carried.

3. Columbia Point Mixed Use Site (Tracts D & E)

Redevelopment Project Supervisor, Brian Moore presented the conceptual plan for Tracts D & E of Columbia Point (the lots just south of the Shilo Inn). Mr. Moore noted between Tract D and the Columbia River are approximately 8 acres of land restricted by a landfill easement. This land will be improved with landscaping and remain open to the public. The conceptual plan presented was developed with input from the Parks Department and the presumption that the area encumbered with a landfill easement would function much like a park. Moore explained that the Economic Development Office is preparing a Request for Proposals (RFP) for the entire site identified in the attached memo to the EDC. The purpose of is to solicit input from the Commission regarding this area and will be useful as the responses to the RFP are evaluated by staff, EDC and Council.

PARKS AND RECREATION COMMISSION COMMENTS:

SUBJECT: Park Hours

STAFF RECOMMENDATION

That the Parks and Recreation Commission recommend Council approve new park hours of sunrise to sunset.

MOTION FOR CONSIDERATION

I move that the Parks and Recreation Commission recommend Council approve new park hours of sunrise to sunset.

BACKGROUND

Current park hours as established in the Richland Municipal Code Chapter 9.22.075 are 5:00 am to 11:00 pm. There are five exemptions to the park hours noted below:

- **A**. Activities for which a permit is issued by the parks and recreation department of the city.
- **B.** Fishing during the hours the park is closed so long as the person fishing has the appropriate state licensing.
- C. Putting boats into and taking boats out of the river.
- **D.** Camping in areas which have been set aside in RMC 9.22.070(D).
- **E.** Individuals utilizing paved walking trails for walking, jogging, and non-motorized cycling activities.

It is also proposed to add to the list of exemptions lighted athletic fields/sport courts.

City of Kennewick park hours are one half hour after sunset until 6:00 am. Pasco and Yakima park hours are 6:00 am to 10:00 pm. Spokane parks are open from 4:00 am to 11:00 pm PDT and 5:00 am to 10:00 pm PST.

Establishing park hours during daylight time (with the exemptions noted above) will limit activity in parks to daylight hours.

SUBJECT: Revised Rules for Paws-abilities Place (off leash Dog Park)

STAFF RECOMMENDATION

That the Parks and Recreation Commission recommend Council approve the revised rules for Paws-abilities Place.

MOTION FOR CONSIDERATION

I move that the Parks and Recreation Commission recommend Council authorize the revisions to the Paws-abilities Place rules per attachment #1.

BACKGROUND

On September 6, 2011 Council adopted (by resolution) rules for Paws-abilities Place.

Staff has been approached by the Tri-City Dog Park Society to add an additional rule to the list which requires that all dos must be spayed or neutered to enter the park.

The Humane Society of the United States provides the following information on their website:

"Unneutered dogs are much more assertive and prone to <u>urine-marking</u> (lifting his leg) than neutered dogs. Although it is most often associated with male dogs, females may do it, too. Spaying or neutering your dog should reduce urine-marking and may stop it altogether.

Other behavioral problems that can be ameliorated by spay/neuter include:

Roaming, especially when females are "in heat."

Aggression: Studies also show that most dogs bites involve dogs who are unaltered.

Excessive barking, mounting, and other dominance-related behaviors.

While getting your pets spayed/neutered can help curb undesirable behaviors, it will not change their fundamental personality, like their protective instinct."

The addition of this rule will provide a safer and friendlier dog park.

EXISTING

PAWS-ABILITIES PLACE PARK RULES

OWNERS / CUSTODIANS SHALL:

Accept responsibility for damage or injury caused by you or your dog.

Bring no more than 3 dogs at one time.

Remain inside fence and voice control of your dog(s).

Control your dog's excessive barking.

Pick-up after your dog(s) and depose of waste using a proper receptacle.

Stop your dog(s) from digging and if necessary, fill holes dug by your dog(s).

Remove all pinch or choke collars from your dog(s) when entering.

Do not bring female dogs that are in heat.

Remove your dog(s) if showing any sign of aggressive behavior.

GENERAL RULES

Dogs shall be at least 5 months old.

Children under 10 are not permitted to enter, and between 10 and 14 years must be supervised by an adult.

Do not approach dogs belonging to others without permission.

Do not bring glass containers or food inside the fence.

Do not run, as this triggers a "prey and chase response", and may lead to injury.

Bicycles, skateboards, motorized vehicles, etc., are not allowed inside the fence.

All dogs shall be spayed or neutered
