I wanted to speak about the human-caused placement of medium sized river rock along side of the walking/biking path in North Richland. At the top of the path beginning at Ferry Street some people have been taking river rocks used to prevent erosion during rainstorms that are located at the top of the path and using them to line either side of the asphalt path that runs the length of the shoreline through the portion described as the North Leslie Groves Natural Area. This is north of the boat ramp and south of Ferry Street near Harris. The rock lining has progressed steadily since early this year until now it reaches about ½ of the length on west side of the path and a short way on the east side of the path.

My issue is that these rocks were placed at the head of the path for erosion control, not to be used as ornamentation in other parts of the park. Second, I believe these rocks could be a potential trip and fall hazard for walkers, who often have to step off the path to the shoulder when bikers or others cause them to veer left or right off the path. They could also be a hazard for bikers who often leave the path for a short time to bike on the shoulder, or for joggers who prefer to run on the shoulder. These hazards would be especially present during the low light times of dawn and dusk. They are also in the way for those people permitted to augment the park with natural plantings. These folks have to bring wagons down to the park full of water jugs to water their plantings.

I have spoken to some of these "rock people" and they claim that it is their right to do what they please with the rocks and they feel they are part of a "community of neighbors working to beautify" the area. One gentleman told me "we voted and you were outvoted"—presumably meaning that my desire for no rocks lining the path was not favored by his "group".

Several people have described this "ornamentation" to me as akin to graffiti. Meaning, that they are "decorating" the park in their own fashion without permission from any formal entity, group, or governmental organization. My question is, if some have to apply for a permit to change

the park, and sign waivers against harm and injury, shouldn't this apply equally to those who change the landscape by lining the path with rocks?

Ultimately, I would like the rocks removed and put back where they came from—at the head of the path or around the Ferry St. "beach" area.
